- Adding UPS's to make the system more reliable
- Grounding Telecom racks to prevent damage to equipment
- Installing high speed wireless connectivity to the bus garage for expansion of high tech security features into the BG facility.

We are also increasing our 1:1 program each year and are moving closer to having a device in every student's hands each and every day. The network switch upgrade will directly support this goal.
